WARRANTY PERIOD:

Machines: One year from the date of purchase.

Parts: 90 days from the date of purchase.

Within the warranty period we will, free of charge, at our option, either repair or replace any part which our examination discloses to be defective because of workmanship or defect in the material. This warranty does not apply if the machine or part has been used in a manner inconsistent with its design or which has been subject to accident, alteration, abuse or misuse or which fails due to lack of care or is the result of improper power supply and specifically does not apply to normal wear.
