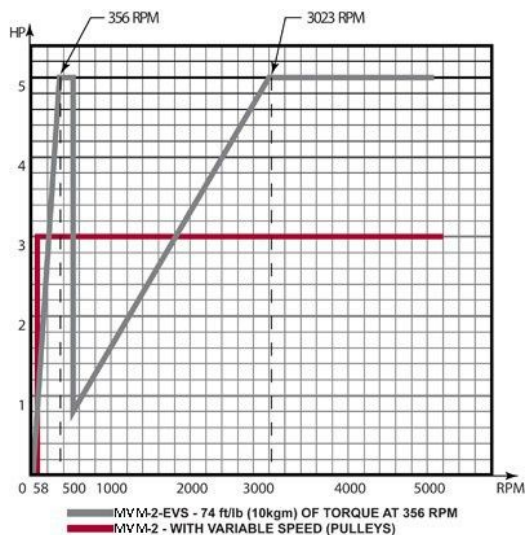

THE SELLER WARRANTS THAT ALL PRODUCTS DELIVERED UNDER THIS PURCHASE ORDER ARE WARRANTED TO BE FREE FROM DEFECTIVE MATERIAL AND WORKMANSHIP FOR A PERIOD OF 1 YEAR FROM THE DATE OF SHIPMENT OR 2112 HOURS. THIS IS BASED ON 8 HOURS A DAY AND 22 DAYS A MONTH, WHICHEVER COMES FIRST, UNDER NORMAL AND PROPER USAGE, OWNED BY THE ORIGINAL PURCHASER, AND NOT ALTERED DURING THE WARRANTY PERIOD. PARTS FOUND TO BE DEFECTIVE BY OUR INSPECTION WILL BE REPAIRED OR REPLACED AT NO CHARGE, F.O.B. OUR FACTORY, PROVIDED THE DEFECTIVE PART IS SHIPPED TO US, FREIGHT PREPAID. THE SELLER IS NOT RESPONSIBLE FOR ANY USAGE FOR WHICH THE MACHINE WAS NOT DESIGNED. THE WARRANTY SHALL AUTOMATICALLY BE NULLIFIED IN THE EVENT OF A COLLISION OR CRASH OF THE MACHINE OR ANY UNAUTHORIZED OR IMPROPER USE OF PARTS, ACCESSORIES OR ADAPTATIONS, AS WELL AS ANY UNAUTHORIZED PARTIAL OR TOTAL

THIS WARRANTY IS EXPRESSED IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED, STATUTORY, OR IMPLIED INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR PURPOSE, AND OF ALL OTHER OBLIGATIONS OR LIABILITIES ON THE SELLER'S PART AND IT NEITHER ASSUMES NOR AUTHORIZES ANY OTHER PERSON TO ASSUME FOR THE SELLER ANY OTHER LIABILITIES IN CONNECTION WITH THE SALE OF SAID ARTICLES. GOVERNING LAW

THE ARBITRATOR SHALL HAVE THE AUTHORITY TO AWARD COSTS OF ARBITRATION AND ATTORNEYS' FEES TO THE PREVAILING PARTY, IF ANY, IN SAID ARBITRATION. ANY AWARD OF ARBITRATOR MAY BE ENFORCEABLE BY JUDGMENT OF CALIFORNIA STATE COURT.
